Recognition Order

WHEREAS in terms of Section 14(1)/Section 15(1) of the NCTE Act, 1993 CHAUDHARY YADUNATH SINGH SHIKSHA MAHAVIDYALAYA, NEAR THE CIRCUIT HOUSE, DAIVERSON ROAD, BHIND-477001, MADHYA PRADESH has submitted an application APW05238/223565 (CO.ED) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting B.ED. (CO.ED) course with an annual intake of 100 on 1-22/2007.

2. AND WHEREAS on scrutiny / perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the SEC teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) /15(3)(a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to CHAUDHARY YADUNATH SINGH SHIKSHA MAHAVIDYALAYA, NEAR THE CIRCUIT HOUSE, DAIVERSON ROAD, BHIND-477001, MADHYA PRADESH for conducting B.ED. (CO.ED) course of SEC of 1 year duration with an annual intake of 100 (SEC) from the academic session 2008-09 under clause 7(1) of NCTE's Recognition Norms & Procedure Regulation 2007 subject to fulfillment of the following conditions :

- I. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(2) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- IV. The institution shall ensure that the required number of academic staff, for conducting the course is always in position.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc. applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:

- (i) Copy of the Application Form
- (ii) Land and Building Particulars.
- (iii) Staff Profile.
- (iv) Recognition letter.
- (v) Information in terms of having fulfilled the norms & standard and other required conditions.

7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

8. Further, if institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.

RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely, CHAUDHARY YADUNATH SINGH SHIKSHA MAHAVIDYALAYA, NEAR THE CIRCUIT HOUSE, DAIVERSON ROAD, BHIND 477001 MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. (CO-ED) course vide order dated 29.02.2008 for an annual intake of 100 students.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 16.01.2015 and the reply was received on 15.01.2015.

AND, WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015.

AND, WHEREAS, the One shri Pawan Dubey filed PIL no-W.P. NO. 2370/2012, W.P. No. 2431/2014 & W.P. No. 3875/2014 in the Hon'ble High court at Jabalpur. The inspection of the institution was conducted u/s 13 by NCTE Hqrs. on 24.03.2015, in the light of the report submitted by the Inspection Team and the observation and recommendations contained therein and analysis of the other relevant records, that institution are required to ensure compliance with regard & received reply was submitted before W.R.C.

AND WHEREAS, the matter was placed in 238th Meeting held on January 01-02, 2016 of WRC and the Committee decided that "... The reply of the institution was examined in the context of the inspection report of the NCTE Hqrs. conducted under Section 13 of the NCTE Act, 1993.

On the basis of the inspection report, the institute was directed to makeup the deficiencies in infrastructural requirements.

One of the deficiencies was the size of the multipurpose hall. In compliance report, the institute has submitted that the deficiencies have been removed and the institute has multipurpose hall of required size. However, on perusal of the record submitted along with the reply dated 08.06.2015, it was found that the size of the multipurpose hall is 50'x20' sq.ft. i.e. 1000 sq.ft. The building map submitted by the institute reflects a seminar hall with 50'x20' area i.e. 1000 sq.ft. that has also been reported by the VT in its report. The institute has not submitted any new proof to justify that it has multipurpose hall of required size.

Hence, Show Cause Notice u/s 17 be issued on the above grounds."

AND WHEREAS, the Show Cause Notice was issued on 14.01.2016 and reply of show cause notice was received on 03.02.2016.

AND WHEREAS, the matter was placed in 252nd Meeting held on May 09-10, 2016 of WRC and the Committee decided that clarification letter to be issued. Clarification letter was issued on 17.05.2016 and reply of clarification was submitted by institution on 31.05.2016.

AND WHEREAS, the matter was placed in 254th Meeting held on June 07-09, 2016 of WRC and the Committee decided that "... The case file was seen. Clarificatory letter was issued on 17/05/2016 and reply was received on 31/05/2016. The institution was informed that its multipurpose hall is only 1000 sq. ft. against the requirement of 2000 sq. ft.

The institution has sent a building plan approved by Nagar Palika, Bhind showing that the multipurpose hall is 112x20 ft. i.e. 2240 sq. ft. However, the earlier building plan showed multipurpose hall as 64x20 ft. Adjacent to this multipurpose hall, there was a room of the size 24x20 ft., by removing the partition, the size of the multipurpose hall should be 88x20 sq. ft. (1760 sq. ft.). It is obvious that there has been an effort to manipulate the size of the multipurpose hall. Thus, the institution does not have the multipurpose hall of 2000 sq. ft.



Hence, Recognition of the institution for B.Ed. course is withdrawn under Section 17 of the NCTE Act, 1993, from the academic session 2016-2017."

AND WHEREAS, the Withdrawal Order issued on 16.06.2016. The institution filed a appeal to the appellate authority Hqs. dated 29.07.2016. Regulatory file sent to Hqs. on 05.08.2016.

AND WHEREAS, the appeal order dated 21.06.2017, The Committee concluded that appeal deserved to be remanded to W.R.C. with a direction to reverse their order of withdrawal dt. 16.06.2016 and restore recognition to the appellant institution.

The council hereby remands back the case of CHAUDHARY YADUNATH SINGH SHYSHA MAHAVIDYALAYA, NEAR THE CIRCUIT HOUSE, DAIVERSON ROAD, BHIND 477001 MADHYA PRADESH to the WRC, NCTE for necessary action as indicated above.

AND WHEREAS, the matter was placed in 280th Meeting held on August 31-September 01, 2017 of WRC and the Committee decided that "...The WRC in its 254th meeting held on June 7-9, 2016 had withdrawn recognition for the B.Ed. course. The institute went in appeal. The appeal committee has remanded the case with direction to reverse the withdrawal order.

Before the withdrawal order is reversed, the institute should clarify the following:-

- (a) The building plans show that the maximum possible area for the multipurpose hall is 88X20 (1760 Sq. Ft.) This was the also the finding of the committee in its 254th meeting.
- (b) There is also a building plan where the dimensions of the multipurpose hall are 112X20 = 2240 Sq. Ft.
- (c) As per the VT Report of 28.02.2017, the dimensions are 102X21.8 = 2223.6 Sq. Ft.

Clarification should be submitted within one month."

AND WHEREAS, the clarification letter was issued on 06.09.2017 and the reply was submitted by the institution on 28.09.2017.

AND WHEREAS, the matter was placed in 285th Meeting held on December 19-21, 2017 of WRC and the Committee decided that "...Since there is confusion regarding structural changes in the building with regard to the multipurpose hall, a VT is required.

VT be constituted. The Collector be requested to nominate PWD Engineer for this purpose together with the VT.

AND WHEREAS, the online VT constituted many times. Inspection conducting on 06.06.2018 by VT members and VT report received in WRO on with CD and enclose documents.

AND WHEREAS, the matter was placed in 295th Meeting held on July 30 - 31, 2018 of WRC and the Committee decided that "...This is a case of appeal. The appellate Authority vide order dated 21.06.2017 has remanded the case to WRC for further processing the application.

The WRC viewed the CD and perused the VT Report. The CD shows that the multipurpose hall has been substantially increased. This is also confirmed by the VT Report which says that the multipurpose hall now is 2263 sq. ft.

Hence, the withdrawal order dt. 16.06.2016 is reversed and recognition is restored."


